The committee decided not to take any further action regarding this matter until further consultation with the cafe manager.</p> <p>The committee were reminded that the police had advised them to register the cameras with the Information Commissioner's Office; and that two people would have to be appointed to check the records.</p> <p>EJ added that the people who had said they were going to install cameras were no longer interested. EJ left the meeting.</p>
