OGT suggested that a quote was needed for the work. EW said that the work could be very expensive especially if the result was unsuccessful again. EJW asked if the work would be done through community council funding. OGT suggested that he ask Meirion to do the work as he was a local, he also suggested that the cost was kept under £500. EJW closed the matter by stressing that Annwen the financial consultant must be contacted regarding the matter.

EJW said that the days of volunteering were over and that the majority of people are asking for money after completing jobs.He then asked if it was possible to establish a caretaker's paid post. OGT answered the question and said that there will be a caretaker appointed in the foreseeable future. He also said that a cleaner's role had been established and Lydia Siviter currently held the position.

<u>7.Adroddiad Y Trysorydd</u>	<u>7.Treasurer's Report</u>
Darllennodd y trysorydd PB drwy'r adroddiad ariannol 2016, datganodd fod y balans banc ym mis Gorffennaf yn £2,000 ac fod incwm misol o tua £450. The treasurer stated that the bank balance stood at £2,000 as of July and added that the monthly income was approx £450 a month. The treasurer also said that holding polling stations at the village hall also increased income as the council paid £405. EJW questioned whether the account had been in the red at one point. PB answered by saying that the account had not
