Increase in fees

See last months minutes for current and proposed fees. The snooker club had agreed to an increase. It was agreed to raise the fees as suggested from 1st April – proposed: Denise Seconded: John Trish would meet with Treasurer/chair/Secretary to discuss her contract

Front doors

Strobe Security Services had been to look at the problems. They gave a ball park estimate in the region of £20,000 to completely redo the frontage to rectify the problem – in his opinion, the present system wasnt fit for purpose. The committee referred the matter to the Trustees to look into what they want to do to move forward. The committee will wait for feed back from them. Nedw (1 of the Trustees) would contact the National Park.

Partitions

2 had now been repaired, but the one nearest the firedoor requires some pieces making. Boston Lodge had quoted \pounds ,000 to do the work as a job, but if a volunteer offered his time, only the materials would have to be paid for. Ben thinks if the parts could be machined, it wouldnt cost much more than \pounds 200 Big thankyou to all the volunteers who have helped so far – it has saved the Hall an immense amount of money.

She would ask for recommendations on facebook to get more quotes. It was suggested that hiring the coffee machine might be a better option. Eryl would look into this as he knew a business that did this.

Insurance renewal

Renewal quote:- Ben had been in touch with various alternatives and had found a company which would do similar cover to that which we had for £400 less premium. Also he needed information of the embezlement, theft of laptops and cafe theft to declare on the proposal form. The Trustees at the meeting agreed for Mick to complete the form, sign and pay the premium on behalf of the hall.
