FFORDD CWT GLAS, DYFFRYN ARDUDWY

GWAHARDDIAD TRAFNIDIAETH TRWODD DROS DRO

Mae Cyngor Gwynedd **DRWY HYN YN RHOI RHYBUDD** ni chaiff unrhyw berson, o 00:01 ar y 26ain dydd o Fai, 2022, beri i unrhyw gerbyd fynd mewn unrhyw gyfeiriad ar hyd y darn hwnnw o'r Ffordd Ddi-Ddosbarth a adwaenir fel Ffordd Cwt Glas, Dyffryn Ardudwy o bwynt ger ei gyffordd gyda'r Brif Heol, Dyffryn Ardudwy (Ffordd yr A496) gan deithio mewn cyfeiriad gorllewinol am bellter o oddeutu 60 metr.

Y ffordd arall yw dilyn Ffordd Cwt Glas, mewn cyfeiriad gogledd orllewinol hyd at ei gyffordd gyda Ffordd Glanrhos ac yna troi i'r chwith. Dilyn y ffordd ymlaen mewn cyfeiriad deheuol gan droi i'r chwith ar y groesffordd cyn Rhes Glanrhos ac yna ymlaen mewn cyfeiriad dwyreiniol, heibio Coed Isaf a Plas Bach, Ffordd Glanrhos hyd at ei gyffordd gyda Ffordd yr A496 ac yna troi i'r chwith. Dilyn y Brif Heol ymlaen mewn cyfeiriad gogleddol yn ôl tuag at y caead ac i'r gwrrthwyneb i drafnidiaeth sydd yn teithio o'r cyfeiriad arall.

Mae angen y gwaharddiad ar sail iechyd a diogelwch i'r cyhoedd ac er galluogi i Beirianwyr BT Openreach allu cael mynediad diogel i rwydwaith uwchben er galluogi atgyweirio cebl diffygol er mwyn atgyweirio gwasanaeth i gwsmer cyfagos.

Disgwylir y gellir cwblhau'r gwaith o fewn 2 ddiwrnod ond nid hwy na 3 diwrnod.

ROAD TRAFFIC REGULATION ACT 1984 SECTION 14(2)
AS AMENDED BY THE ROAD TRAFFIC
(TEMPORARY RESTRICTIONS) ACT 1991

GWYNEDD COUNCIL – CLOSURE OF THE UNCLASSIFIED ROAD KNOWN AS
FFORDD CWT GLAS, DYFFRYN ARDUDWY

TEMPORARY PROHIBITION OF THROUGH TRAFFIC

Gwynedd Council **HEREBY GIVE NOTICE** that from 00:01 hrs on the 26th day of May, 2022, no person shall cause any vehicle to proceed in either direction along that length of Unclassified Road known as Ffordd Cwt Glas, Dyffryn Ardudwy from a point near to its junction with the High Street, Dyffryn Ardudwy (the A496 Road), travelling in a westerly direction for a distance of approximately 60 metres.

The alternative route is to follow Ffordd Cwt Glas in a north westerly direction up to its junction with Ffordd Glanrhos and then turn left. Follow the road in a southerly direction, turning left at its crossroads before Glanrhos Terrace and then onwards in an easterly direction, passing Coed Isaf and Plas Bach, Ffordd Glanrhos up to its junction with the A496 Road and then turn left. Proceed along the High Street in a northerly direction back towards the closure and vice versa for vehicles travelling in the opposite direction.

The closure is necessary on health and safety grounds to the public and to enable BT Openreach Engineers to gain safe access to overhead network cables to renew and restore a nearby customer's out of service.

It is anticipated that the work will be completed within 2 days but will not exceed 3 days.
